- This complex, unparalleled, internationally important and visually highly striking landscape is centred on the copper workings on Parys Mountain and extends to include the associated port of Amlwch in north east Anglesey. The main part of the site comprises a huge, mainly hand-dug, opencast mining pit comprising an 18th- to 19th- century copper mine and waste tips, with an extensive attendant complex of processing features and structures superimposed on earlier workings dating from the prehistoric and possibly Roman and medieval periods. The area also includes the remains of an associated transport system, settlements, Amlwch town, port and ore processing works, as well as an axial field system and ribbon settlement. It is included on the Cadw Register of Landscapes of Outstanding Historic Interest

Occupation in the Roman period has also been demonstrated by the presence of artefacts, including coins, a brooch and copper cakes, and earthworks from this period. There are several medieval and post-medieval chapels and churches in the area, while other post-medieval constructions include Plas Bodewryd, built in the 15th to 16th centuries, and an 18th century dovecote. Character-wise, this is an area of gently rolling rural fields and farms inland from the coast, which contains the first windfarm to be built on Anglesey and which now dominates the visual impact.
